- 2. Goods of shop at 79 Tai Nan Street occupied pavement adjacent to Lai Chi Kok Road/Tai Nan Street Sitting-out Area and alley of 83 Tai Nan Street.
- 3. Shop-front extension problem by a pharmacy at G/F 110 Prince Edward Road West.

The above problems were referred to FEHD, EPD, DSD and HyD, for respective follow up actions.
